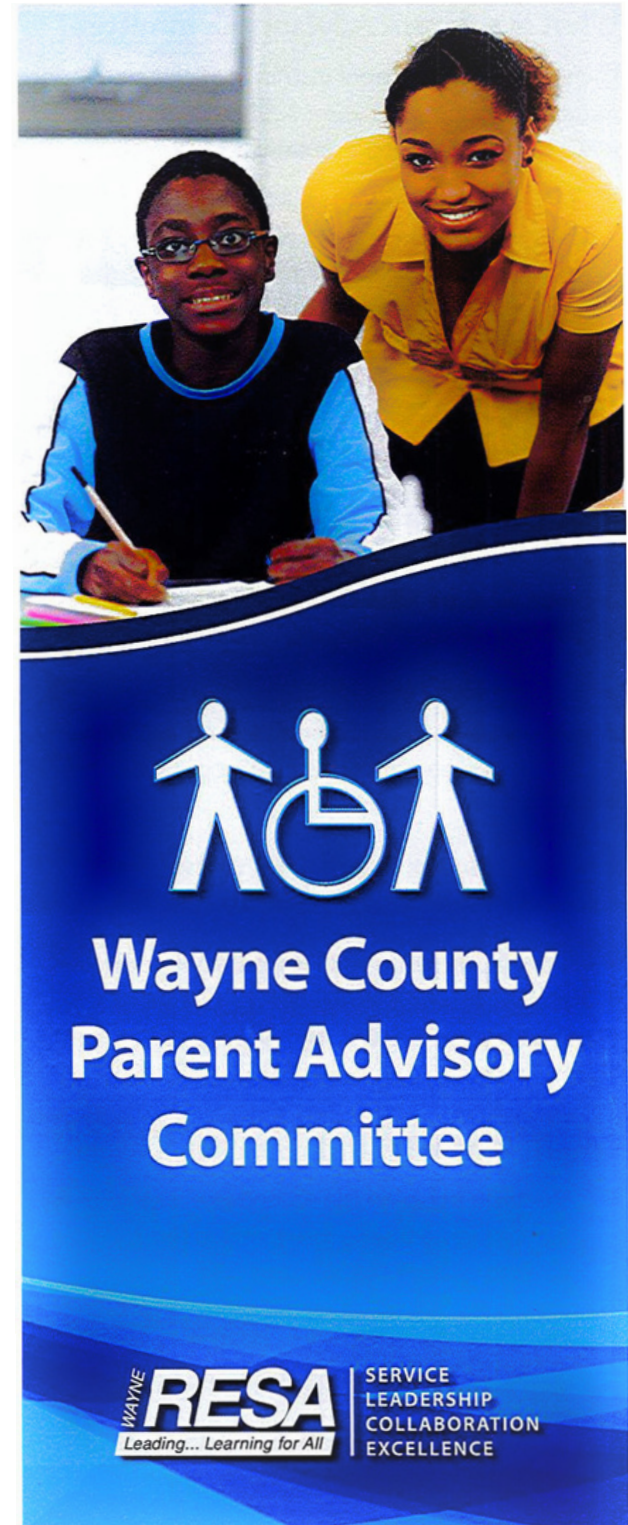

## What is a Parent Advisory Committee?

Each intermediate school district in Michigan is required to appoint a Parent Advisory Committee (PAC) composed of representatives from each of its constituent districts.

The representatives "shall consist only of parents of students with disabilities with at least one parent from each constituent local school district and public school academy. ..."

(Rule 340.1838 Michigan Department of Education Revised Administrative Rules for Special Education, February 2018).

In Wayne County, this is the WCPAC. WCPAC members often serve as an information source and advocates for other parents in their community.

With a total population of approximately 1.8 million, Wayne County is the most populous county in the State of Michigan and the 18th most populous county in the nation.

There are 33 school districts in 43 Wayne County communities serving approximately 226,000 students. Additionally, there are 108 Public School Academies (PSAs) serving 64,000 students for a combined total of approximately 290,000 students in public schools County-wide.
