- The ISBN for *The Boy Who Harnessed the Wind Picture Book Edition* does not appear accurate. The correct ISBN appears to be 978-0803735118. Can you confirm the correct ISBN for this title? Per Attachment #2, Wayne RESA asks vendors to indicate whether their price quote is for paperback or hardcover versions. We will consider quotes for hardcover and paperback; however, the ISBN provided in the RFQ is for paperback version of 'The Boy Who Harnessed the Wind' (ISBN #978-0545591881)
- Section C, article 4 states: "Any quotation received after the time stipulated will not be considered, but will be recorded, filed and shall remain sealed/unopened. Quotations received by facsimile transmissions or electronic mail will not be considered valid unless also received by mail or delivery by the stated deadline." This is in contradiction to Section c, article 2 which states: "Quotations must be received via email...." Can you confirm that submissions should be received solely by email? Due to COVID-19, Wayne RESA's facility is closed to the public. As a result, Purchasing Services has temporarily suspended the requirement for hardcopy proposals. Per #2 of Section C (Quotation Process, page 4 of the RFP), we are <u>only</u> accepting emailed copies of proposals. Proposals should be emailed to <u>huntere@resa.net</u>.
 Please note: Attachments #4 and #5 are required to be notarized (signed and stamped). This
- requirement still stands and should be incorporated into proposals.
 3. Some of the ISBNs do not match up correctly with the titles. IE the ISBN for Allie's Basketball Dream 9780140564402 is actually the book Goggles. Are we OK to list the correct ISBN on the form? We will follow correct title and author as listed on the request.
