Julianna Molnar, District Occupational Therapist, Livonia Public Schools on Picky Eaters

The drive to feed your child is as strong as the drive itself, in other words if you are extremely driven to ensure your child is fed it is expected

Presenter confirmed this is not in place of seeing a doctor or a nutritionist As caregivers we are trained by those we care for. We can't stop introducing new foods and can't reinforce their behavior (that's xyz, you don't like that)

Concern comes when there is poor weight gain, when mealtimes become battles, <20 foods, breathing problems, and ongoing coughing, gagging & chocking

While there may be GI issues at play that is outside of the scope of this discussion and requires a medical team

Great tips to support healthy eating habits and how to engage a picky eater including positive eating behaviors and eating skills. Eating skills include demonstrating or explaining chewing and using mirrors to help kids see and understand what is going with their mouths while they're eating as well as describing food outside of the mouth before it goes in the mouth (grape example where so much

happens when a person puts a grape in their mouth – talk about it, see it, take it apart, etc BEFORE they put it in their mouth)
