#### PROBLEM:

"Ensuring that our educational system is a doorway to opportunity – and not a point of entry to our criminal justice system – is a critical and achievable goal," Attorney General Holder said in a statement last summer. By bringing together government, law enforcement, academic, and community leaders, I'm confident that we can make certain that school discipline policies are enforced fairly and do not become obstacles to future growth, progress, and achievement. (Secretary Duncan, 2011)

No truer words have been spoken, with respect to how *government, law enforcement, academic, and community leaders* should respond to what is an unprecedented increase in the removal of Black and Brown boys from traditional public school. Suspensions and expulsions have left a trail of tattered lives of children placed into alternative schools that simply serve as 'holding tanks' until their inevitable trek to youth detention centers and eventually adult incarceration facilities (Dunbar, 2013).
